Chico touched in needing to obtain most current water bills in order to complete the turf rebate program request. Turf removal extension will expire end of March 2016. Turf removal should be done and complete by Saturday. Saturday they will mulch. Andre to look at color around the rocks across from monument sign and provide a bid to place some irrigation around the rocks for the color.
