#### **FINANCIAL REPORT REVIEW:**

### **COMMITTEE REPORTS:**

Architectural - The Board discussed the current applications. No action was required.

**Equestrian** – The Board discussed the horse boarding agreement and insurance coverage that will be increased to cover all liability. There are 16 stalls rented and upgrades to the area are in process. It was mentioned that the trash was not picked up regularly.

**Financial** – The Association is better than budget YTD. Mr. Blank also discussed the Y/E audit results that confirmed missing reserve funds of \$128,000 From Opus Bank. The potential loss has been reported to the insurance carrier and should be 100% covered. There should not be any loss to the association. It is estimated the claim for reimbursement by the insurance will take place in the next 30-90 days.

Members were advised the Board of Directors are taking action to recover all the HOA funds and will assist the insurance company in the investigation to recover all funds. Members will be kept advised regarding the situation and a recall election will be put in process to remove Mrs. Calderon from the board due to her refusing to resign because of the misappropriation of reserve funds.

Tennis Court Committee - No discussion.

**Landscape** – Chico from Andre attended and discussed various bids and status of current work orders approved for the community. Chico will get a cost to add the color four (4) times per year in the regular contract.

#### **OPEN FORUM:**

The following issues were discussed in open session:

- Trails above stables needing cleaning
- Metal grate at Topaz and Turquoise next to the pump station needs fixed by the City. Mgt to contact City and advise it's a liability issue.
- Equestrian Arena Issues and opposition to renting to outside horse owners. Board had approved \$125.00 for rentals from non-owners. There is a special indemnity agreement signed by owners. It was pointed out to the board that the CC&Rs provide for exclusive rights and use only by HOA owners. Rental to outsiders is being done on a trial basis and may be stopped with a 30 day notice. Members commented that members should be asked what they feel should be done with the old closed down stables aboute the clubhouse.
- ATV and dragger being purchased for use at the arena. Board approved \$400 ATV M/Blank S/Friel
- Tree trimming needed at 15207 Turquoise Cir
- Shower at pool area not working well
