#### **QLD BUSINESS:**

**2012 Draft Budget Review** – The Board approved the 2012 budget. It was agreed that some additional adjustments were needed in the reserve study regarding slope reserves and some of the zero life remaining items.

**Restating of CC&Rs** – The Board carried over discussion of the CC&R restatement. The board will review the questionnaire from the attorneys office for needed additional input.

**Association Rules Review** – The review of the rules was carried over. Darlene Baca – Pool Rules Charles Blank – Tennis Court Rules Clubhouse – Julie Calderon

Clubhouse Maintenance Proposals – The Board carried over the proposals.

**Janitorial Maintenance Proposals** – The Board approved A1 Pools to start service as of Dec 15<sup>th</sup> if possible and cancel Cal-Swim Pool Service. M/Calderon S/Blank

**2011 Year End Audit / Tax Proposals** – The Board approved the audit proposal by Schonwitz & Company at a cost of \$1050. M/Blank S/Calderon

**Stall Agreement Review** – Many of the owners have submitted the required applications and insurance information requested. Any that have not submitted will be sent a notice to vacate the stalls.

#### **NEW BUSINESS:**

**Wi-Fi Service** – The Board approved sending out the Wi-Fi Notice to members in the statement. Members will be required to be in good standing to receive the access code from management.

Tennis Court Resurfacing - Carried over

**Tennis Court Bench Proposal** – The board approved the proposal by Kala to replace both benches at the tennis courts. Price not to exceed \$3690.00 M/Calderon S/Bakke

**Cyber-Rain / Weather-Matic Controller System** – The Board approved withdrawing the proposal to proceed with Cyber-Rain and proceed with Weather-Matic and Andre.

**Clubhouse Painting Proposals** – The Board approved KCC Painting to do the painting of the clubhouse at \$2850.00 both inside and out.

Access Entry Systems – The board tabled the project at this time.

**Edison Billing Reimbursement** – The reimbursement request is in process. Julie is obtaining all the back Edison Billings between 2006 through 2011, These will be submitted to CMS for reimbursement by an association they handle. Management will submit a letter requesting the total be reimbursed.
