COMMITTEE REPORTS:

Architectural- No report

Equestrian- Mr. Howard reported that the stalls are at approx 50% occupancy and the center is running smoothly.

<u>Financial</u>- Jesse Cunningham reviewed the financial report with the board in open session. As of 10/31 the association is \$19,000 better then budget due to interest income. There is a possibility of the water billing being \$2000 over budget by the end of the year.

NEW BUSINESS:

Fall Tree Trimming Proposal – The Board approved the proposal for multiple tree trimmings in the community at a cost of \$9855. The Board carried over the bid pending review by the tree trimming committee.

Arborist Proposals – The Board is still reviewing the proposals so carried over the proposals from Total Landscape, Treesmith Enterprises, and CLS Landscape Management.

Clubhouse Bulletin Board — The Board approved a replacement "Outside" Two Door 24" High by 36" Wide cork backed "Outdoor" bulletin board at the clubhouse at a cost of \$235 plus installation.

SWINGSET REPAIRS – The damaged swings have been removed pending additional bids for new (up to code) swings being installed. Management is obtaining a second bid for repair and replacement options for the equipment.
