LANDSCAPE PROPOSAL

Total Landscape has submitted two proposals:

- (1) 2206 Turquoise- install 70- 1 gallon Parbafolium for a total cost of \$231.70. Motion was made by Charlie, seconded by Brian, carried unanimously to approve this proposal.
- (2) 2530 Turquoise- replace a two inch leaking backflow device. The original proposal was for \$1,200.00. Leo of Total Landscape indicated that was an incorrect proposal as Carbon Canyon gets a special price. Management was unaware of the price at the time of the meeting. Motion was made by Charlie, seconded by Jesse, carried 3-0, with Bill abstaining to give Bill and Brian the authority to approve the cost of the backflow device replacement after verification of price from Total.

CPR PAYMENT

Previously CPR had issued an invoice for \$1,089.00 when they moved the Association's files from the previous Management company to Carbon Canyon's clubhouse. The Board was disputing the amount and CPR offered a price of \$900.00 instead. Motion was made by Charlie, seconded by Brian, carried unanimously to approve payment to CPR for \$900.00.

COMMUNITY OPEN HOUSE

Community Open House to be held at Equestrian Center. It is being scheduled to be held on May 19, 2007. Brian will produce a flyer. This will be held in lieu of the Annual Easter Celebration. Motion was made by Charlie, seconded by Bill, carried unanimously to approve this event and allow a \$500.00 expenditure.
