- Landscape Committee- Bill informed the Board that the color had been installed
 at the monuments. He also informed the Board that the pre-emergent needed to be
 completed. A motion was made, duly seconded and unanimously approved to accept

 Bill. Management was instructed to code the invoice to 6020 (landscape Extras).
