IF YOU SEE ANYTHING SUSPICIOUS PLEASE CONTACT THE CHINO POLICE DEPARTMENT AT 909-628-1234; IF THERE IS AN IMMEDIATE THREAT PLEASE CALL 911.

ADDITIONALLY, PLEASE GET TO KNOW YOUR NEIGHBOR'S AND WATCH OUT FOR EACH OTHER; EXCHANGE TELEPHONE NUMBERS AND KEEP AN EYE ON YOUR NEIGHBOR'S HOME IF THEY ARE OUT OF TOWN OR JUST AWAY FOR THE DAY. AND IF YOU SEE YOUR NEIGHBOR'S GARAGE DOOR OPEN LATE INTO THE EVENING OR OPEN FOR AN EXTENDED PERIOD DURING THE DAY TAKE A MINUTE TO KNOCK ON THEIR DOOR TO ENSURE EVERYTHING IS A-OK.

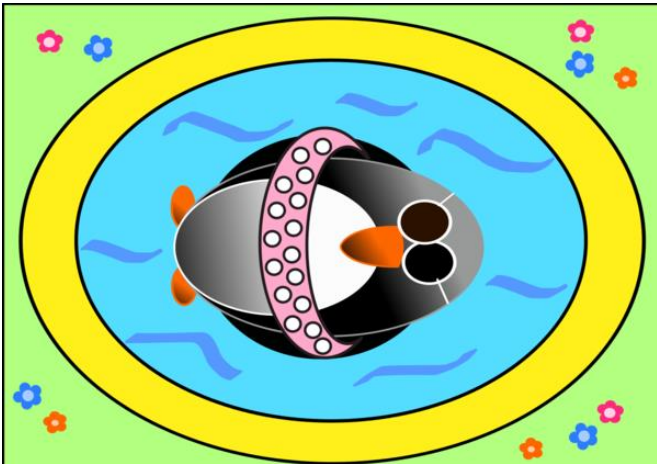
NATIONAL NIGHT OUT
