EACH VEHICLE CAN BE SAFE LISTED UP TO FIVE (5) DAYS IN A THIRTY (30) DAY WINDOW. IF A VEHICLE IS NOT SAFE LISTED, THE PATROL COMPANY WILL ISSUE A WARNING CITATION. IF THE SAME VEHICLE IS FOUND IN **VIOLATION WITHIN NINETY (90) DAYS, IT WILL BE** TOWED AT THE VEHICLE OWNER'S EXPENSE. AFTER NINETY (90) DAYS, THE CITATION IF YOU HAVE ANY WINDOW RENEWS. OFF SITE OWNERS

PLEASE ADVISE YOUR TENANTS OF THE PROVISIONS OUTLINED IN THE ASSOCIATION'S GOVERNING DOCUMENTS AND PROVIDE THEM WITH A COPY OF THE RULES AND REGULATIONS, INCLUDING STREET PARKING RULES AND ANY OTHER PERTINENT NOTICES. TRASH CANS

ANOTHER REMINDER THAT ALL TRASH CANS MUST BE PUT BACK BEHIND YOUR GATE OR IN YOUR GARAGE WITHIN 24 HOURS AFTER PICK UP. ADDITIONALLY, PLEASE DO NOT LEAVE YOUR TRASH AT THE CURB OR IN ALLY'S THAT DOESN'T FIT INTO YOUR TRASH CANS. THIS IS NOT ONLY UNSIGHTLY BUT VERY INCONSIDERATE OF YOUR NEIGHBORS. NO ONE WANTS TO SEE YOUR TRASH SIT OUT FOR DAYS! IN MANY CASES THE ASSOCIATION HAS TO PAY TO HAVE SOMEONE PICK UP AFTER YOU. YOU CAN CALL WASTER MANAGEMENT FOR A SPECIAL PICK UP THREE TIMES A YEAR FOR FREE, THEN PUT YOUR EXCESS TRASH AT THE CURB OR ALLY ON THE DAY OF TRASH PICK UP. PLEASE ADHERE TO THESE REQUIREMENTS SO YOU DON'T RECEIVE A VIOLATION LETTER FROM THE ASSOCIATION.

DRIVEWAYS

PLEASE REMEMBER THAT YOU CAN'T PUT OIL PANS, CARPET, CAT LITTER, CARDBOARD, ETC. ON YOUR DRIVEWAY TO CATCH OIL. AND PLEASE HELP US KEEP THE COMMUNITY ATTRACTIVE BY REMOVING OIL STAINS FROM YOUR DRIVEWAY. THANK YOU!
