ADDITIONALLY, WE HAVE HAD SEVERAL INCIDENTS OF ILLEGAL FIREWORKS IN THE PAST YEARS ALONG WITH AN ENORMOUS AMOUNT OF CARS PARKING IN THE FIRE LANES AND IN FRONT OF FIRE HYDRANTS; A COMBINATION THAT COULD CAUSE A DISASTER. PLEASE NOTE THAT ILLEGAL FIREWORKS ARE DEFINED BY CALIFORNIA AS ANY FIREWORK THAT EXPLODES OR LEAVES THE GROUND AND THERE IS A \$1000.00 FINE IN THE CITY OF CHINO FOR DISCHARGING ILLEGAL FIREWORKS. WE WANT EVERYONE TO ENJOY THEMSELVES THIS HOLIDAY BUT WE ALSO WANT TO ENSURE THAT EVERYONE IS SAFE AND THAT PROPERTY ISN'T DAMAGED. PLEASE NOTE THAT THE POLICE WILL BE CALLED IF ILLEGAL FIREWORKS ARE USED IN CRYSTAL LANE SO PLEASE THINK TWICE BEFORE YOU DECIDE TO SET THEM OFF.

ALSO, PLEASE MAKE SURE YOUR PETS ARE LOCKED UP OR ARE UNABLE TO ESCAPE YOUR YARD. PETS CAN BECOME VERY FEARFUL OF THE EXCESSIVE NOISE. THANK YOU FOR YOUR ANTICIPATED COOPERATION AND ENJOY THE HOLIDAY.

Any recreational vehicle parked on the street longer than 48 hours will be towed, without notice, at the vehicle owner's expense.
