TOLERANCE AND COMMUNITY LIVING

Recently I had the opportunity to review college information sheets and I was struck with how close the idea of living in a college dorm, and respecting the rights of others, has in common with living in any close proximity community such as the Shores. A healthy community is made up of individuals who each have a part in the success of the community. One college has three criteria that serve as their model and make sense for any community attempting to create a positive living environment.

Be Cooperative: Living as closely to one another as we do requires compromise and communication. We must reach agreement on mutual expectations, we must listen to others when conflict arises, and we must come together as a group to solve community problems.

Be Civil: Each of us must feel that we have a rightful and recognized place in the community. This sense of personal worth is reinforced when we treat one another in a civil fashion which affirms the dignity and respect that each of us is due. Dealing with disagreements or differences must be done in a positive manner. The health of the community requires nothing less than this and the basic level of tolerance that is required of each of us.

Be Involved: When we get involved in our community, we invest in it, we help it grow, flourish and reach its potential.

Our involvement brings about activities and improvements. We provide service to help others and ourselves. We help our community become an even better place to live. We recognize problems before they become insurmountable.

If you have a neighbor who has created some concerns for you such as too many lights reflecting in your home at night, tree branches hanging over your fence, or an uncontrolled barking dog who enjoys too much freedom when your neighbors are at work, let them know in a positive manner and see if the situation can be easily resolved. We all need tolerance when living in close proximity to one another. It is amazing how often dealing with negative situations can be quickly resolved when each party is treated with dignity and respect.

Via Rene: The dates for Via Rene painting are Mar 14-June 17. Take a trip down Via Morena to see what the new paint colors look like on the houses.


