# A. Adoption of Proposed Fine Policy

## B. City of San Clemente Drain Inspection

A motion was made, seconded and unanimously carried to approve the proposal from Scott English Plumbing for the jetting and camera line to the common area slope drain across from 34 Santa Clara, for a total cost of \$1,650, to be expensed from the Reserve, Contingency line item (#4500).

## C. Fuel Modification Maintenance Proposals

The Board reviewed (5) estimates for the trimming of the internal fuel modification zone. A motion was made, seconded and unanimously carried to approve the proposal from Mission Landscape for areas A, B, C, and D, at a total cost of \$65,120, to be expensed from the Reserve, Fuel Modification/Fire Abatement line item (#9005).

# D. No Trespassing Sign Proposals

No action taken as there is already a "No Trespassing" sign present on the common area slope at Calle Pastadero.
