The Landscape Committee provided an update on the current status of the fuel modification project and advised that the 10 Calle Pastadero irrigation controller has failed, and that it will be replaced under warranty.

#### C. Architectural Review / View Maintenance Committee

The Architectural Review Committee submitted an application from 36 Paseo Alba to the Board for appeal from the owners for the installation of a wall. A motion was made, seconded and unanimously carried to approve the application with conditions, pending receipt of a plan view.

#### D. Homeowner Relations Committee

A motion was made, seconded and unanimously carried to approve a cost not to exceed \$25.00 for the purchase of a "No Trespassing" sign to be installed on the service road swing gate at the entrance from 10 Calle Pastadero, to be expensed from the Operating, Contingency line item (#8900)
