- 4) Via Coco and Via Santa Clara to remove and replace plant material in the amount of \$2266.66.

Board reviewed the proposals for the controller boxes. Wendy Rhodes made a motion and seconded to approve the All-Trade proposal to only scrape to the galvanized metal and not paint. All in favor.
