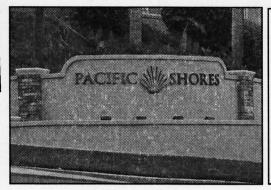

### Common Area Slope Maintenance & Other Landscape Information

The Landscape Committee would like to inform the homeowners that slope maintenance safety is an Association priority. First and foremost, the height, removal, and type of vegetation on the exterior slopes is mandated by the Orange County Fire Authority. The Association is required to maintain those fuel modification areas per the OCFA standards. These exterior slopes will be maintained in phases with vegetation cut low, or cleared, in order to provide slope stabilization, and deter fire from spreading.

Many of our large, high density bushes are at the end of their life cycle, overgrown, and impede irrigation to other plants and flowers. This may result in some vegetation being removed, or trimmed lower than previous years.

Our slopes will be maintained to best address the health and needs of the all plants, considering conditions for the drought, watering restrictions and fire safety for the community.

Please note our landscape workers have specific instructions on the work they do each day, and must have a work order to address other areas of concerns. Please make sure your contact is through Seabreeze Management Company to express your concerns and requests for work orders.

Trees are scheduled to be trimmed two times per year. May will be the next scheduled tree trimming and will include camphors, ficus and queen palm trees.
