

At the October 21, 2015, Board of Directors meeting the Board adopted a change to the monthly assessment for Fiscal Year 2016.

The original notice included the Annual Policy Statement and Annual Budget Report mailed to you on June 18, 2015 contained a notice that the monthly assessment was increased to \$152.40 per month, per home effective August 1, 2015.

A notice and new budget was mailed to inform you that the Board has reconsidered the increase and the following is hereby noticed:

Effective with the assessment due February 1, 2016, the monthly assessment will be reduced to \$140 per month, per home. This change will be reflected in the statement you will receive mid-January.

- If you are set up on ACH the amount will be automatically adjusted.
- If you are set up on an auto-payment schedule, please be sure to advise the appropriate banking institution of the rate adjustment that is to take place, February 1, 2016.

Please note you are still obligated to pay the \$152.40 for January 2016 monthly assessment.

# **Holiday Tree Collection**

CR&R will be collecting the Christmas trees and greenery beginning the day after Christmas, for a period of two weeks.

- Remove all ornaments, lights, and stands.
- Cut your tree in half if it is over 6' tall.
- Place your tree curbside on your collection day next to your automated containers.
