# UNFINISHED BUSINESS

### Complaints on Tree Issues from Gold Course blocking views

The Board discussed removal of trees on Golf Course slopes to come up with a plan for removal and/or replacement. The Tree Committee presented a policy/procedure. Motion was made by Jim Domen, seconded by Fred Shultz to send it out to the community for 30 day review and comment. Joe Capotrio is concerned about the mission statement and that it should include information about damage from roots and buildings. He stated that trees are an added value and is concerned about the neighbor notice. Joe Capotrio was opposed. Motion carried.

#### Budget Draft & Reserve Study

Joe Capotrio, Treasurer reported. This item was tabled for the next meeting. The Board will submit questions to the Reserve Analyst next week.

#### **NEW BUSINESS**

#### Landscape Proposals

Motion was made by Joe Capotrio, seconded by Fred Schultz to approve the purple lantana installation to replace the stressed bougainvillea at the entrance. Motion carried unanimously. A separate motion was made by Jim Domen to deny the bid to renovate slope on Emerald Downs, seconded by Fred Schultz. Motion carried unanimously. A separate motion was made by Jim Domen, seconded by Fred Schultz to replace the pine tree Bryant home. Motion carried unanimously.

#### Common Area Maintenance Proposals

Motion was made by Jim Domen, seconded by Fred Schultz to approve the excess fire lane signage removal for \$20 per sign. Joe Capotrio was opposed. Motion carried. A separate motion was made by Jim Domen to approve the power washing of the pavers, install shepherds hooks at the west pool area gate and clean the storm drain filters. seconded by Joe Capotrio. Motion carried unanimously. announcing it to the membership in attendance at the meeting, a separate motion was made by Joe Capotrio to make an emergency decision (pursuant to Civil Code Section 1363.05) to add a pool monitor before this weekend, to address resident's concerns communicated during this evening's open session. The motion to make an emergency decision was seconded by Fred Schultz and carried unanimously. A motion was made by Fred Schultz to approve a pool monitor from ProVision at \$17.50 per hour for 8 hours per day for 10 days (Fri/Sat/Sun 1-9 plus Labor Day). Motion carried unanimously.
