- provide identification and proof of residency if asked by an Association representative or an employee of the Association, i.e. OC Patrol.
- Each member is entitled to bring no more than four (4) guests into the pool area at any time. Members must stay with guests while they are at the pool area. Unattended use of the Association's facilities by guests is prohibited. Members are responsible for any damage to the Association's property caused by themselves, their family members, tenants or guests.
- Alcoholic beverages are prohibited from the pool facility at all times.
- Glass containers or glass objects are prohibited in the pool areas.
- Large flotation devices, rafts, surf boards, boogie boards or any other swim toys or equipment are not allowed in any of the Association pools.
- No dogs are allowed in the pool area.
