#### 2019 RECONVENED ANNUAL MEETING-ELECTION

#### STATUS OF THE BOARD

Following the board meeting, four (4) board members resigned. Currently, the Board does not have enough members to function as a board. Therefore, the only items that will be addressed, until a quorum is established on the board, are legal matters or emergencies.

### **RESERVED PERMIT PARKING PROJECT**

At this time, the process of implementing a parking permit/reserved parking project is not being pursued. Please note, the Board acted within the CC&Rs, when considering this parking project, reference page 15 of the CC&Rs, under 2.5.7 Regulations and Restrictions by Board, in which it reads, *"The board has the power to: (a) establish additional rules and regulations concerning parking in the Common Property, including designating "parking", "guest parking" and "no parking" areas; (b) prohibit any vehicle repair, maintenance or restoration activity in the Properties if it determines in its sole description that such activity is a nuisance; and (c) promulgate rules and regulations concerning vehicles and parking in the Properties as it deems necessary and desirable."*
