# STATUS OF SAN LORENZO COMMUNITY PROJECTS UNDERWAY & PLANNED

**ANNUAL TERMITE INSPECTIONS –** Termite inspections have found live termites and evidence of mice in one attic. Owners must go online and schedule their Unit's inspection. It is important that owners schedule appointments and get the inspection done ASAP. <u>www.termite.work/sanlorenzo/</u>

**TERMITE & DRY ROT WOOD DAMAGE REPAIRS** – A contract has been awarded and work to replace termite or dry rotted wood elements of residential buildings found during last year's termite inspection. Building access for the contractor will be scheduled with Unit owners.

**COMMUNITY BUILDING PAINTING –** The Association will evaluate painting contractors proposals and select a contractor to paint wood, concrete board siding, metal such as gutters and downspouts, and garage doors soon.

**POOL HOURS BACK TO REGULAR SCHEDULE** – Pool and spa hours and FOB access to the pool area have returned to the normal schedule for the Summer -- Sunday – Thursday: 6:00 a.m. to 10:00 p.m. and Friday – Saturday: 6:00 a.m. to 11:00 p.m.

**SHEET METAL REPAIRS START IN MAY** -- Repair of defective sheet metal flashing and stucco weep screed will start May 15. This is scheduled as a quick turnaround and all Units with back yards requiring access will be contacted. It is important for owners to provide timely access to work areas.

## GOT HOUSEHOLD HAZARDOUS WASTE?? - GIVE IT TO ORANGE COUNTY WASTE PROGRAM

<u>Free Household Hazardous Waste and E-waste</u> <u>Disposal for OC Residents</u>

Leftover household products that contain corrosive, toxic, ignitable or reactive ingredients are considered Household Hazardous Waste (HHW). Products such as paints, cleaners, oils, batteries, and pesticides containing potentially hazardous ingredients require special handling when you dispose of them.





Compact Fluorescent Tubes and Fluorescent light bulbs should be taken to the HHW Center for proper disposal as well because of the mercury that they contain.


Automotive products including Antifreeze, Automotive batteries, Carburetor and fuel injection cleaners, Fuel additives, Motor oil, and Transmission and brake fluid are accepted at the HHW center.

Electronic-waste such as televisions, tablets, cell phones and computers can also be taken to the Anaheim Collection Center -- 1071 N. Blue Gum Street, 92806. But smoke detectors are not accepted because they contain radioactive isotopes. It is an easy drive through with staff taking the HHW out of the trunk of your car or the back of your SUV. All HHW should be immobilized to prevent a hazardous waste spill in the back of an owner's vehicle. For more information, see the fact sheet at:

## STILL USING FLUORESCENT LIGHTS?? THEY WILL SOON BE UNAVAILABLE IN CALIFORNIA

Starting January 1<sup>st</sup>, most CFLs and eventually all fluorescent lights shorter than 8 feet in length will be unavailable in California because of the passage of AB 2208. The bill prohibits a screw or bayonet base type compact fluorescent lamp on and after Jan. 1, 2024, and a pin-base type CFL or linear fluorescent lamp after Jan. 1, 2025. Home improvement stores have begun to no longer carry the soon to be phased out lights and are featuring LEDs in several color ranges. The Association has shifted from 13watt 4100 Kelvin CFLs in the building



sconces to 5.5-watt 4100 Kelvin LEDs which will last longer and use less electricity for the same luminosity.



#### OWNERS ASKED TO CHECK BACK YARD DRAINS FOR WORKING CONDITION

San Lorenzo Unit owners with back yards (Plan 1 & 2) are asked to check all of the builder installed yard drains for functionality. Especially important are drains close to the building and those just inside the perimeter steel fencing. Drains next to the building help reduce the possibility of water entering the home. Water is not

permitted to flow from backyards and down slopes because of storm water pollution prevention requirements. Ensure soil has not covered the drains and water does

not flow onto the slopes but into the drains that run to the streets.

### UTILITY CLOSETS ARE NOT FOR STORING PERSONAL ITEMS

The building utility closets are not to be used for personal storage. The Association is having a contractor clean out old paint from the building painting program in 2017 and other debris found in the utility closets. Extra roofing tiles are sometimes stored in the utility closets to be available for urgent roof repairs in the community. Other personal materials need to be removed.
