Dear Neighbor,

The San Lorenzo HOA Board is honored to serve you and the families throughout our community. In July, we continued to work diligently on your behalf to address the following issues to improve our quality life.

### **Fiscal Accountability**

- As previously highlighted, the 2010 year-end budget audit confirmed we entered 2011 with a balanced budget.
- We continue to get the most "bang for our buck" in HOA dues through our ongoing emphasis of monitoring vendor performance and costs.
- o Here is a summary of the HOA dues we've saved by reducing vendor costs:
  - ✓ Landscape services 2010 total \$11,220 (\$935 savings per month); at the last meeting the Board approved an additional reduction in vendor fees bringing the 2011 year to date savings to \$4,044 (\$337 savings per month).
  - ✓ Building maintenance services (handyman) We approved a new vendor last meeting which will save the HOA approximately \$2,304 annually (\$192 savings per month).
  - ✓ Patrol Services In 2010, the Board hired a new vendor which would save the HOA approximately \$1,980 annually. After further performance and cost assessments, we made another vendor change at the last meeting which will provide an additional savings of \$516 annually (\$43 savings per month) or an overall annual saving of approximately \$2,500 (\$200 per month) moving forward. Please note, the reduced costs will also respond to resident requests to diversify patrol times and will now feature one day patrol and two night patrols.
  - ✓ Pest Control This year (May) the Board approved to increase services with existing vendor by adding rodent bait stations at no additional charge saving the HOA approximately \$456 per year.
  - ✓ Pool Services At the last meeting the Board approved to keep the same vendor we've had since 2008. However, the vendor agreed to reduce their rates which will save the HOA approximately \$480 annually.
  - ✓ In summary, a new Board philosophy of demanding excellent vendor service while pursuing lower rates has resulted in \$11,308 annual estimated 12-month savings.
- Last month, we maintained a balanced budget with current year net income of \$1.435.
- A new collections policy continues to collect late HOA dues payments in 2011. Many of these collections go back to prior years.
- Hopefully in August we will be reimbursed from the developer (Shea) the \$11,567.47 that is due the association. This will help our cash position since we have already disbursed the funds to the vendor for the repairs.
- The board is reviewing the reserve study analysis and will present it a future HOA meeting.
