At this point, the remaining homes that have not scheduled inspections with Fire Harris Protection will be charged a \$150.00 service fee by the vendor in order to have the inspection completed. Notices will be mailed to each owner's attention advising you of the importance in having this inspection completed. We realize this project is an inconvenience; however it is a mandatory test that must be done this year. Every home must be inspected before the report can be submitted to the appropriate authorities. Therefore your cooperation is sincerely appreciated and needed.

UTILITY CLOSETS OUTSIDE YOUR BUILDING MAY NOT BE USED FOR STORAGE OF PERSONAL PROPERTY

We included this article in the last two newsletters and would like again to remind everyone that the utility closets outside your building are not considered storage units. The Board and Management are requesting you inspect the closets outside your home to ensure it is not being utilized as storage for personal property. The utility closets on the exterior of each of our buildings are common areas; not to be used by individual residents for storage or any other personal purposes.

The closets are to be used exclusively by utility vendors ONLY. Please remove any of your personal items and please refrain from any future use of these closets.

The Board approved Humburg & Associates to complete the needed utility door replacements and repairs. This project will take place over the next 45 days in anticipation of the painting project that is scheduled for September 2016. Any items left in the utility closets as of July 20, 2016 will be removed and disposed of. Management reserves the right to remove any personal property and dispose of those items after that date. Please note that any items removed by the Association will be disposed of and not stored so again, please make sure that you remove any personal property you have stored in those utility closets as soon as possible.
