## CHANGES TO OUR FRONT ENTRANCE AREAS

By now you've noticed that we are beginning the transition of our front entry area to a more contemporary look, utilizing more drought tolerant plant materials.

In keeping with the mandated cuts to our allowable water use here in the landscape areas of our community, we are moving forward with the installation of new drought tolerant plant materials in a number of areas. Previously, we upgraded the entry median area, giving the community a new, fresh and more contemporary look. Next, that was followed by the large slope on Emerald Downs.

Now, we are doing the same in the grass area located at the entrance to the community, again, trying to add more color and more contemporary plants helping to improve the overall look and appearance here in San Lorenzo.

## TIME WARNER BULK CONTRACT

We are still looking for additional resident feedback in regard to a possible bulk contract with Time Warner Cable. Please email any comments to <u>taryn@stonekastle.com</u> to share your thoughts regarding this option. Currently, our community is serviced by 3 vendors for your television needs and 2 for your internet. San Lorenzo residents currently have the option of receiving TV through either DirecTV, Time Warner or AT&T.

Time Warner has recently contacted the community with a proposal to offer Time Warner television, Internet and telephone services to the entire community. Although you can choose to receive Time Warner services now on your own, they have proposed selling a bundled discounted package for the entire community. An example of the discounted bulk rate pricing is shown below and the fees would be increased annually until the full rate is reached in 3 years.

If we were to adopt their proposal, Time Warner would charge the entire community, all 174 homes, for a basic level of service. From there, each individual homeowner would have the right to add additional services e.g. faster Internet or other pay channels, etc., in addition to the basic services and fees covered. The individual homeowner would be responsible for whatever added services they choose.

We would like your feedback as to whether this is something you would potentially be interested in. Please keep in mind that pursuant to their proposal, it would be an all or nothing situation where if we accepted their proposal, all homes in the community would receive the basic services at the basic charge. Again, any additional services would be received, at your expense.

If this is something you're interested in, or not interested in, please let us know. Your feedback is important to us. You would still have the right to keep the services you are already using but those costs would continue at your expense. In other words if you pay for AT&T services, you could keep your chosen services but then you'd pay for the Time Warner services as well as those you have at this time.

If the board decides not to adopt the proposal, then things would remain the same as they are now with each homeowner free to choose whichever company or services they like or want to continue using.
