Please be advised that all roadways and parking areas must be clear. All vehicles must be out of respective areas by 7:00 AM and may return at 7:00 AM the following morning. Vehicles will be towed immediately and the towing company will be on standby. Please do not walk or drive on wet coat seal. Please be careful turning your wheels, as the seal coat will remain tender for approximately four (4) weeks. Automobiles should continue to roll while turning wheels and avoid turning wheels while sitting still. Please see color map on the other side of this newsletter for the phasing schedule, when it is your date for slurry seal, please park on the opposite side of the community. Parking citations will not be issued during this community project.

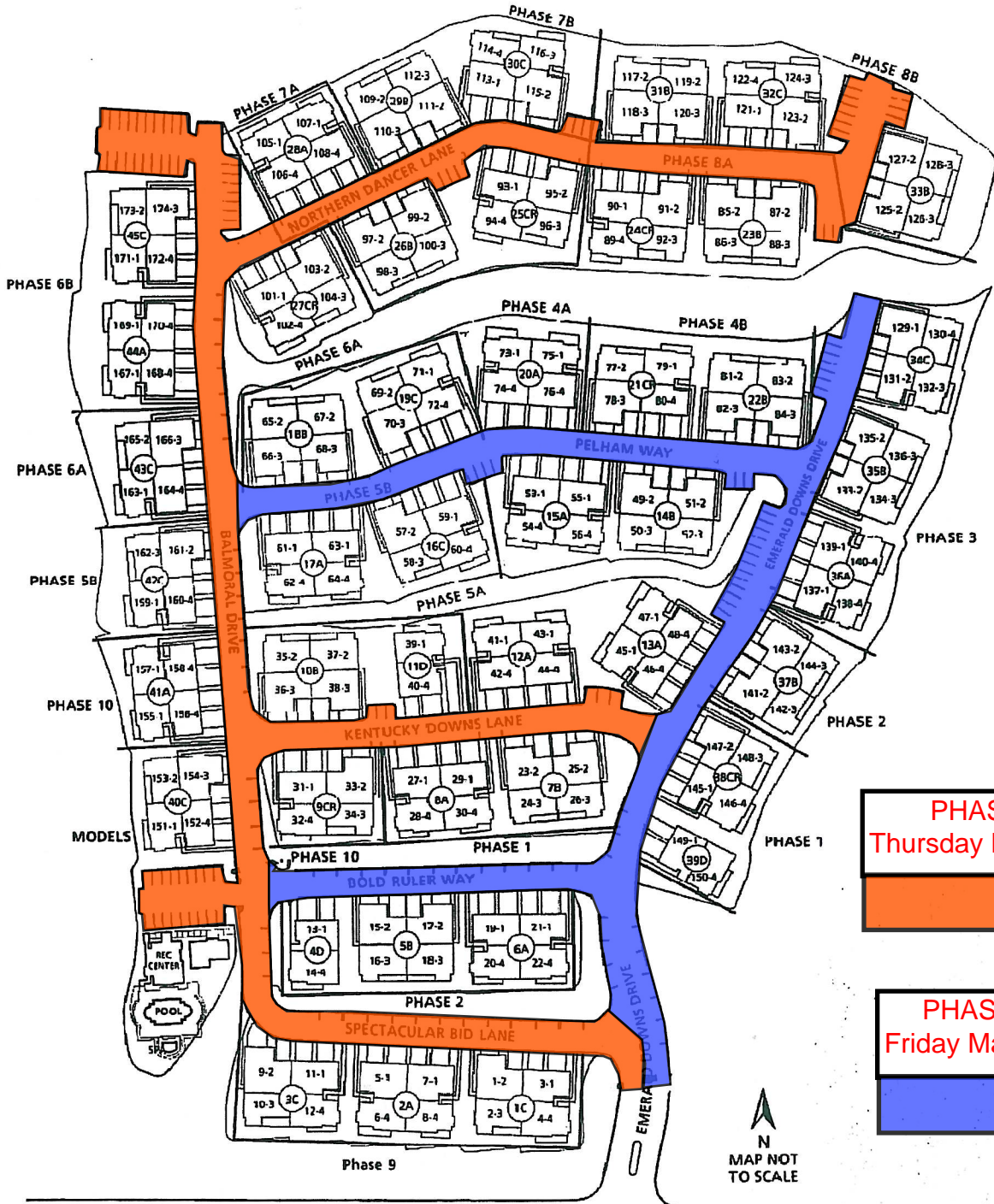
