BLOCK PARTY – WHAT A GREAT PARTY! We hope you made it to the first ever San Lorenzo Block Party. WROUGHT IRON FENCE REPAIRS – The Board of Directors recently approved a contract with Pro Tech for wrought iron fence repairs through out the community. If you have chicken wire, planting material on the fence or dirt pushed up against the fence, it must be removed immediately so the repairs can be made expeditiously. Please also be reminded that chicken wire and metal type materials and planting materials are not allowed on the common area fencing. Repairs will commence by November 19th.

2010 BUDGET APPROVAL/DUES INCREASE – The Board of Directors recently went through a detailed, in depth review of the budget as they prepare for the next fiscal year. Due to the mandated water conservation restrictions and raise in the water rates coupled with the increase in delinquencies, the Board did reluctantly vote to raise the dues \$6 for 2010 to cover these unfortunate events.

AMERICAN FLAG DISPLAY – the Board and Management have recently received complaints regarding the display of the American Flag. Please be advised that there is a Federal law in place called the "Freedom to Display the American Flag Act of 2005". A condominium association may not adopt or enforce any policy, or enter into any agreement, that would restrict or prevent a member of the association from displaying the flag of the United States on residential property within the association with respect to which such member has a separate ownership interest or a right to exclusive possession or use.

KEVINS' CRÈME BRULE RECIPE – One of the many desserts that was a hit at the block party was from a neighbor up on Northern Dancer! Thanks for sharing your wonderful recipe, Kevin!

1 quart heavy cream, 1 vanilla bean, split and scraped, ½ cup cane sugar, Raw sugar (for the burnt topping), 6 large egg yolks, 2 quarts hot water. Preheat the oven to 325 degrees

Place the cream, vanilla bean and its pulp into a medium saucepan set over medium-high heat and bring to a boil. Remove from heat, cover and allow to sit for 15minutes. Remove the vanilla bean and reserve for another use.

In a medium bowl, whisk together $\frac{1}{2}$ cup regular cane sugar and the egg yolks until well blended and it just starts to lighten in color.

Add the cream a little at a time, stirring continually. Pour the liquid into 6 (7-8 ounce) ramekins. Place the ramekins into a large cake pan or roasting pan. Pour enough hot water into the pan to come halfway up the sides of the ramekins. Bake just until the Crème Brule is set, but still trembling in the center, approximately 40 - 45 minutes. Remove the ramekins from the roasting pan and refrigerate for at least two hours and up to 3 days.

Remove the Crème Brule from the refrigerator for at least 30 minutes prior to browning the sugar on top. Place large grain raw sugar over top of each, dump off excess sugar. Torch top till golden brown. Allow the Crème Brule to sit for at least 1 minute before serving.
