Dear Neighbors,

Fall is here and the San Lorenzo HOA Board is honored to serve you and the families throughout our community. In August, we continued to work diligently on your behalf to address the following issues to improve our quality life.

## Fiscal Accountability

- $\circ\,$  Last month we maintained a balanced budget with year to date net income of \$1,356.00.
- We continue to get the most "bang for our buck" in HOA dues through our ongoing emphasis of monitoring vendor performance and costs.
- Here is a summary of the savings created by reducing vendor costs through August 2011:
  - ✓ Landscape services \$4,044 total; \$337 per month
  - ✓ Building maintenance services (handyman) \$2,304 total; \$192 per month
  - ✓ Patrol Services \$516 total; \$43 per month
  - ✓ Pest Control \$456 total; \$38 per month
  - ✓ Pool Services \$480 total; \$40 per month
  - ✓ In summary, a new Board philosophy of demanding excellent vendor service while pursuing lower rates has resulted in \$650. per month.
- Our new collections policy also continues to secure late HOA dues payments with \$9,586 received so far this year.
- Similarly, last month your HOA Board worked to collect a reimbursement of \$11,567.47 from Shea Homes for roof repairs.
- **Planning For Our Future** We are reviewing a reserve study analysis conducted by an independent party and will present the results by the November 15<sup>th</sup> deadline. The board has asked for some items to be reviewed and some new items to be included in the reserve study for calendar year 2012.

# **Quality of Life & Aesthetics**

- Clubhouse Faux Painting Proposals The Board approved a proposal for Faux Painting of the clubhouse interior walls.
- Utility Closet Assignments There are utility closets that hold meters and some that do not throughout the community. The Board has crafted a draft policy to

allow for resident use of the empty utility closets. The policy will be sent to residents for 30-day comment period.

- Board Member and Open Forum Code of Conduct policy After receiving input and further revisions, the draft policy will be sent out for an additional 30-day comment period.
- Dog Park and Play Ground Many homeowners have expressed an interest in having a dog park and play area for children and grandchildren in our community. The Board is looking into this option and is welcoming input from the community for the potential project.
