Your Homeowners Association Board is happy to serve you, and would like to share some updates about our neighborhood, from the September HOA meeting, regarding fiscal matters, quality of life and aesthetics matters, and open forum questions and answers.

### **GENERAL DISCUSSION**

At the Regular Meeting held on September 9, 2013, general discussion was held amongst the members in attendance:

- o <u>Parking Lot Lighting at Clubhouse</u> Board commented on the lighting project that was already on the agenda. It is being worked on for the October meeting.
- o <u>Speed Signs</u> Members were concerned that the speed limit sign on Emerald Downs is not visible enough to guests and residents. Management was directed to inspect and advise at the next meeting.

#### **COMMITTEE REPORTS**

Clubhouse Committee – The committee is seeking volunteers for the Clubhouse Committee. Without volunteers, reservations to the clubhouse will be more difficult to organize, and less convenient for the owners who want to reserve it.

- o Street Committee There were no new action items to report at this time.
- o **Social Committee** Fred Schultz, Chairperson, updated the Board on the New Year's Eve party. There is concern about the amount of work that the party entails, and the lack of volunteers. - o **Tree Committee** The Committee announced that the City has finally accepted the request for the removal of the trees. The Chairperson will start coordinating with the golf course, and landscaper, to have the trees that are marked removed, along the slope behind Balmoral. Subsequent phases will begin soon thereafter, for the trees along the golf course slopes behind Northern Dancer and Emerald Downs.

- o **As a Reminder,** the speed limit within the community is 15 MPH. For the safety and protection of all, please drive safely, and obey all posted signs within the community.
- o Garage Doors- Please remember that your garage door is **not to be kept open when not in use**. Please be considerate of your neighbors, as we all take pride in the appearance of our community.
- o **Doggie Bag Dispensers** Will be installed at the two mailbox locations in the community. Please always remember to pick up after your pet. If it's your pet, it's your responsibility.

### PET RESPONSIBILITY

Despite repeated requests, pet waste remains a problem within San Lorenzo. In an effort to ensure that all pet owners clean up after their pets, the above mentioned doggie bag dispensers will soon be installed. There should be no excuses for not picking up after your pet!

Per the San Lorenzo Community Handbook: "Pet owners must pick up after their pets on all community property including, but not limited to, the front and back of the buildings, adjacent streets and landscape. Any resident not complying with this provision may be subject to special assessments."
